

# OGUN STATE GOVERNMENT PUBLIC NOTICE



## FILING OF PAYE TAX RETURNS FOR 2016 AND MONTHLY PAYE REMITTANCES SCHEDULE

The Ogun State Internal Revenue Service (OGIRS) wishes to inform the general public that in line with the provision of **Section 81(1-3)** of **Personal Income Tax Act, 2011 (as amended)** that all employers of labour in the state (Public & private Organizations) are statutorily obliged to file their PAYE Tax returns for 2016 on or before January 31, 2017.

Any employer who contravenes the provisions of this section shall be liable on conviction to a penalty of N500,000 in case of a body corporate and N50,000 in case of an individual. [Section 81(3)].

The Annual Tax Returns for employers of labour should contain the following details:-

- i. PAYE Annual Returns Form (H1)
- ii. Withholding Tax (WHT) returns for (contracts, rent dividends etc.) in line with sections 41, 69, 70 and 72 of the Act.
- iii. Development Levy.
- iv. A schedule of all withholding tax deductions made by showing names and addresses of beneficiaries, amount, tax deducted and nature of services.
